

**HERE Transportation License for data received between June 30, 2017 and June 29, 2018****5.11 HIFLD Transportation Data Base Licenses**

NGA will have the following specific data rights: Non-exclusive, irrevocable, perpetual, and non-transferable rights with respect to HIFLD Transportation data. NGA will have unrestricted right to access, use, copy, modify, reproduce, release, distribute, perform, display, prepare derivative works, or disclose the HIFLD Transportation Data in executing NGA's Homeland Security mission. NGA will have the right to provide the HIFLD Transportation data with these same rights to other users as outlined in the Base License sub-paragraphs below in the execution of their Homeland Security, Homeland Defense and Disaster Preparedness missions.

**5.11.1 HSIP Base License Requirement(s):** The Base license will include Paragraphs 5.11.2, 5.11.3, 5.11.4, 5.11.5, and 5.11.6.

**5.11.2 United States Federal Government Data Release License**

All of the data (base data and required updates) shall be provided with a United States Federal Government license, to include the unrestricted right to access, modify, reproduce, release, perform, display, distribute and/or otherwise use the data by all agencies and offices of the Federal Government and its contractors (for Government purposes), to include the National Guard Bureau units supporting Homeland Security, Homeland Defense, and Disaster Preparedness missions. Derivative products created from the dataset will be releasable to mission partners.

**5.11.3 Designated State Government Partners Data Release License**

The same license rights detailed in paragraph 5.11.2 will be extended to the following state government agencies and any others designated by DHS that fulfill similar mission functions as the following agencies:

- a) State Fusion Centers
- b) State Emergency Operations Centers (EOCs)
- c) State GIS Coordinators
- d) State National Guard Joint Operations Centers, and
- e) State Emergency Management Coordinators.

The data will be released via DHS coordination in support of Homeland Security, Homeland Defense, and Disaster Preparedness missions. These rights include the unrestricted right to access, modify, reproduce, perform, display, and/or otherwise use the data.

#### **5.11.4 Canadian Government Partners License**

The same license rights detailed in paragraph 5.11.2 will be extended to include NGA Canadian Government partners\* involved in the Cross Border Infrastructure Program (CBIP), a Canada-US (CANUS) data-sharing program developed to ensure a coordinated response to CANUS geospatial requirements in support of Homeland Security and related activities. These rights include the unrestricted right to access, modify, reproduce, release, perform, display, distribute and/or otherwise use the data.

\* Includes, but is not restricted to, National Resources Canada, the Department of National Defense, and the Canadian Ministry of Public Safety. This license does not allow release of the data to provincial or local Canadian authorities. Derivative products (vector products only) created from the dataset will be releasable to mission partners.

#### **5.11.5 Non-Federal\*\* Emergency Data Release License**

During the time of a presidentially-declared national emergency or crisis, non-Federal governmental disaster/emergency response agencies and/or personnel supporting the Homeland Security, Homeland Defense, and Disaster Preparedness missions will have the full license for the HIFLD Transportation Data as detailed in paragraph 5.11.2. These rights include the unrestricted right to access, use, modify, reproduce, release, perform, display, distribute and create derivative products from the data (derivative products will be hardcopy or raster products without database characteristics. Derivative products may be released to any mission partner). These license rights would exist only for the duration of the specific event or disaster, as well as throughout all pre- and post-event preparatory or wrap-up phases directly associated with the event or disaster.

\*\*The designated lead Federal agenc(y/cies) will determine which non-Federal agencies receive access to this data under presidentially declared national emergencies or crises. Derivative products created from the dataset will be releasable to mission partners.

#### **5.11.6 HSIP Quinqupartite Countries Data Release**

During the onset of specific, major planned events (e.g., the 2010 Vancouver Olympics) or unforeseen natural or man-made disasters, support from some or all of the Quinqupartite mission partner countries (Canada, Great Britain, Australia, and New Zealand) may be required. The Quinqupartite Countries Data Release expands on the rights detailed in paragraph 5.11.2. and provide that the data be released to the Quinqupartite mission partner countries during such events and/or disasters. This sharing of data will exist for only the duration of the specific event or disaster, as well as throughout all pre- and post-event preparatory or wrap-up phases directly associated with the event or disaster.

### **5.12 HSIP Optional License Requirements**

#### **5.12.1 HIFLD Data Disclosure License during Non-Emergency to State and Local Government Partners option**

If exercised, this license option will provide non-Federal governmental disaster/emergency response agencies and/or personnel supporting the Homeland Security Homeland Defense, and Disaster Preparedness missions the rights to view the data via a Federal Government owned, secure (password protected) electronic network. These users are not permitted to

download the data to their own systems under this license (absent the upgrade of this license or the direct purchase by the user of an appropriate license).
